# **DESCRIPTION**

Techniseal® Dirt & Grease Cleaner for Pavers effectively removes motor-oil and grease stains (barbecue) from concrete pavers. Recommended for sealed surfaces and fresh stains, it dissolves, dislodges and encapsulates grease, thoroughly cleaning without leaving any oily film after rinsing.

# **DIRECTIONS**

#### **BEFORE YOU BEGIN**

Wear rubber gloves and safety goggles. To ensure the results will meet your expectations, **ALWAYS TEST** the product on a small hidden area.

#### **APPLICATION**

On a sealed surface, wet the stain before applying product; on a bare surface, apply dry. Cover the stain **generously** with Dirt and Grease Cleaner; **let work for 2 to 3 minutes;** reapply product and scrub with a nylon scrub brush; do not let product dry on the surface; **rinse thoroughly with water.** Repeat if necessary.

**Important:** An oil spot that has penetrated the material may resurface within 24 hours following cleaning; if this occurs, lighten the stain using Techniseal® Professional-Grade Oil & Grease Remover.

\*For bare srfaces and older, more stubborn stains, use Techniseal® Professional-Grade Oil & Grease Remover (121-591).

# STORAGE AND SHELF LIFE

Product must be kept in its original, unopened and tightly sealed container, and stored in a dry and well ventilated place with controlled temperature (40°F to 75°F). Keep sheltered from weather and direct sunlight. In proper storage conditions, the product's shelf life is 3 years following production (see date on packaging).

#### Danger
