### APPLICATIONS

---

- Sealed or bare surfaces
- Pavers and slabs made of concrete
- Driveways, pool decks, patios, terraces, commercial parking lots, pedestrian areas, etc.

### PROPERTIES

---

- Removes stains caused by steel, rusted metal objects and fertilizers
- For bare or previously sealed surfaces
- Will not discolor pavers; does not contain muriatic acid

### DESCRIPTION

---

Techniseal® Rust Remover for Pavers takes out rust from concrete pavers. It effectively dissolves stains caused by dripping rusted water, steel streaks, fertilizer granules<sup>1</sup>, etc. Since it contains no muriatic acid, it won't damage the material. Ideal for bare or previously sealed surfaces.

<sup>1</sup>To remove fertilizer stains from a large surface, it is recommended to use Techniseal® Paver Prep.

### DIRECTIONS

---

#### BEFORE YOU BEGIN

- Do not use on natural stone, wet-cast pavers or poured concrete.
- Wear rubber gloves and safety goggles.
- **ALWAYS TEST** on a small hidden stain to ensure that result meets your expectations.

#### APPLICATION

Wet the stain and cover it generously with Rust Remover. Using a nylon scrub brush, scrub the stain until it is dissolved; rinse immediately with water. If rust persists, repeat the operation.

**IMPORTANT:** Pavers with efflorescence may appear spotted after the use of Rust Remover. For a uniform result, clean the entire surface with Paver Prep from Techniseal®. Rust streaks left by metal snowploughs may be difficult to remove.

**STORAGE AND SHELF LIFE**

Product must be kept in its original, unopened and tightly sealed container and stored in a dry and well ventilated place with controlled temperature (40°F to 75°F). Keep sheltered from weather and direct sunlight. Properly stored, the product’s shelf life is 3 years following production (see date on packaging).
